

ExpoTile Terms and Conditions

1. Stand Bookings

A stand booking is confirmed once ExpoTile has received a completed **ExpoTile 2027 Stand Booking Form**.

By submitting a completed booking form, the exhibitor confirms that they are authorised to make the booking on behalf of the company named and agree to these Terms and Conditions.

All stand bookings are subject to availability.

2. Stand Prices

The following stand prices apply to ExpoTile 2027:

Stand Size	Price
2m x 1m stand space (includes a trestle table and chairs if required)	£600+VAT
4m x 1m stand space (includes two trestle tables and chairs if required)	£1,200+VAT
Bespoke Stand	POA

Members of The Tile Association receive a 50% discount on the listed stand spaces.

3. What is Included

A **2m x 1m stand** includes:

- 2m x 1m exhibition space
- One trestle table
- Chairs

A **4m x 1m stand** includes:

- 4m x 1m exhibition space
- Two trestle tables
- Chairs

Any additional equipment, display materials or requirements are the responsibility of the exhibitor unless otherwise agreed in advance.

4. Payment

An invoice will be issued following confirmation of the stand booking.

Payment is due within **30 days of the invoice date**.

Where a booking is made fewer than 30 days before ExpoTile 2027, payment is due **immediately upon receipt of the invoice**.

5. Cancellations

Cancellations must be made in writing to **expotile@tile.org.uk**.

Cancellations received **within 14 days of the event are non-refundable**, and the full stand fee will remain payable.

For cancellations received more than 14 days before the event, any refund will be subject to the terms agreed with ExpoTile at the time of cancellation.

6. Stand Allocation

ExpoTile is responsible for the allocation and positioning of all exhibition stands.

Exhibitors may submit stand location requests, and every effort will be made to accommodate these where possible. However, specific stand positions cannot be guaranteed and ExpoTile reserves the right to make changes to the exhibition layout or stand allocation where necessary.

7. Stand Use and Sharing

Stands may only be used by the company named on the booking form and may not be transferred, sublet or shared with another company without prior approval from ExpoTile.

Companies within the same corporate group may share or exhibit from the booked stand, subject to prior notification to ExpoTile.

8. Exhibitor Responsibilities and Insurance

Exhibitors are responsible for ensuring that their stand, displays, equipment and activities are safe and suitable for the event.

Each exhibitor must hold appropriate and adequate insurance relevant to their participation at ExpoTile, including any cover required for their staff, equipment, products and activities.

Exhibitors are responsible for complying with any relevant health and safety requirements and any instructions provided by ExpoTile or Hilton Birmingham Metropole.

9. Changes to the Event

ExpoTile reserves the right to make reasonable changes to the event where necessary, including changes to the exhibition layout, stand locations, timings, date or venue.

If circumstances outside ExpoTile's reasonable control prevent the event from taking place as planned, ExpoTile may postpone, relocate or cancel the event. Exhibitors will be informed as soon as reasonably possible of any significant changes.

10. Damage and Property

Exhibitors are responsible for their own property, equipment and display materials throughout the event.

Exhibitors may be held responsible for any damage caused by them, their staff, contractors or equipment to the venue, fixtures, fittings or other property.

ExpoTile cannot accept responsibility for the loss, theft or damage of exhibitors' property, except where liability cannot legally be excluded.
